### To Whom It May Concern,

Periodic re-evaluation regarding the distribution of equities in the subsegments of Equity Market has been completed and the equities to be traded in the BIST Stars Market, BIST Main, and Sub-Market as of 01/04/2021, have been determined.

As it is known, pursuant to the provision in the Clause 4 of Article 37 of the Equity Market Directive, titled Criteria for Determining Markets, transfer of the equities with an actual Free Float Rate (FFR) of less than 5% to the Pre-Market Trading Platform (PMTP) has become possible. Accordingly companies traded on the Exchange with an FFR of less than 5%, have been granted a deadline until 31/03/2021, to those who applied to Borsa İstanbul. The shares of those companies, that have not increased their FFR above 5% until the given date, will be traded in PMTP as of 01/04/2021.

Within this framework, an evaluation has been made to determine the markets in which equities will be traded in the upcoming period. According to the results of this evaluation, the new market distribution of all relevant equities, which will be effective as of 01/04/2021, is given in Appendix-1 and the list of differences showing the previous and new markets of the equities is given in Appendix-2.
