To Whom It May Concern,

The fees applied within the scope of the "Borsa İstanbul Data Distribution Agreement" (DDA), which regulates the fees and policies regarding the use and distribution Borsa İstanbul market data, will be updated as of 1st January 2022. Please find attached the revised version of the Borsa İstanbul Data Fee Schedule which is the Addendum 3 of DDA.

Additionally, price level provided in the Equity Level 2+ data package will be increased from 10 to 25. Furthermore, F&O (Derivatives) Level 2+ data package will be introduced in DDA and its content will be similar to the content of F&O Level 2 with 25 price levels.

All mentioned changes will be effective as of 1st January 2022.

General Provisions:

- (1) Distributors and Sub Distributors that receive Real-time Data shall not be charged for the Delayed and End of Day distribution of the same data. Distributors and Sub Distributors that receive Delayed Data shall not be charged for the End of Day distribution of the same data.
- (2) Distributors that receive SASE Level 2 data shall not be charged for SASE Level 1 data. Similarly, Distributors that receive MNSE and/or MSE Level 2 data shall not be charged for MNSE and/or MSE Level 1 data. However, Distributors authorized to distribute both the Borsa İstanbul Level 1+ and Level 2 data shall pay both of the fees specified for these data.
- (3) The Distributor shall provide a deposit (or letter of guarantee) to Borsa İstanbul the Data requested for itself and each of its Sub Distributors as specified below:
 - Distributors with real-time Level 1+ distribution license: 7,500 TL.
 - Distributors with real-time Level 2/2+ distribution license: 20,000 TL.
 - Distributors with real-time Level 2/2+ distribution license and having more than 20 Sub Distributors: 100,000 TL.

Deposit is not applied for the Third Party Content. In case of a change in the licenses of Distributor, Borsa İstanbul may request additional deposit, which will be limited to the amounts mentioned above. Payment obligation of the Distributor under the DDA resulting from its failure to comply with the terms and provisions of the DDA and/or non-fulfillment or partial fulfillment of its obligations under the DDA could be met

solely out of the deposit in whole or in part without prejudice to other rights and remedies available to Borsa İstanbul at law under the DDA. In such case, if the DDA is in force, the Distributor is liable to cover the shortfall in the deposit within the given time.

- (4) The Initial Technical Connection Fee will accrue and become due and payable immediately after the signing of the DDA and should be paid in full within (30) days after the DDA enters into force. The Distributor is not required to pay the Initial Technical Connection Fee for the subsequent years as long as the DDA remains in force.
- (5) The Annual Technical Connection Fee and Additional GMI User Annual Fee will accrue and become due and payable immediately after the signing of the DDA and should be paid on a pro rata basis within (30) days after the DDA enters into force. The Annual Technical Connection Fee and Additional GMI User Annual Fee will accrue and become due on the first day of January and should be paid in advance by the fifteenth (15th) day of each February at the latest for the subsequent years as long as the DDA remains in force.
- (6) 50% discount in Technical Connection Fixed Fees is applied if the Distributor is receiving the Data from Access Point by means of methods not requiring co-location, such as MetroEthernet or if the Data is received via an authorized network provider. 75% discount in Technical Connection Fixed Fees is applied if the Distributor is receiving the Data only from a web service. No discount shall be applied for the Merkezi Kayıt Kuruluşu (MKK) Data. Additionally, for the Additional GMI User Annual Fee and if the Data is received from an Access Point outside of Turkey then no discount shall be applied. Technical Connection Fixed Fees specified for Merkezi Kayıt Kuruluşu (MKK) Data shall not be applied for the Distributor receiving only the PDP Data among the Merkezi Kayıt Kuruluşu (MKK) Data.
- (7) Sub Distributors and Secondary Distributors are not required to pay the Technical Connection Fixed Fees. If the Data is received via an authorized network provider of Borsa İstanbul then the Initial Technical Connection Fee shall not be applied among the Technical Connection Fixed Fees.
- (8) The monthly fees calculated based on the Reporting by the Local Distributor should be paid to Borsa İstanbul until the fifteenth (15th) day of the following month. The monthly fees calculated based on the Reporting by the Overseas Distributor should be paid to Borsa İstanbul within 30 calendar days after the invoice date.
- (9) The Distributor shall pay the monthly fixed fees for itself and for each Sub Distributor in 6 months intervals and these fees will accrue and become due and payable on the first business day of January and July. If the authorization start date for the distribution of the Data received by the Distributor for itself and/or its Sub Distributer is in the midst of the 6 months period, the Distributor shall pay the monthly distribution fees of the current month and the remaining months of the period and these fees will accrue and become due and payable at the authorization start date. The Distributor is required to pay the amounts due hereunder for itself and for each Sub Distributor to Borsa İstanbul by the fifteenth (15th) day of the following month at the latest.
- (10) The fees that will accrue for the Merkezi Kayıt Kuruluşu (MKK) Data will be invoiced by MKK and the payments shall be made to MKK. The fees that will accrue

for the İstanbul Takas ve Saklama Bankası (Takasbank) Data will be paid to Takasbank.

- (11) Technical Connection Fixed Fees accrued hereunder shall not be returned in case of revocation or non-renewal of authorization or termination of DDA.
- (12) In the case of revocation or non-renewal of authorization or termination of DDA, the distributor fixed fees related to the following months of the current period shall be returned to the Distributor if there are not any liabilities of the Distributor towards Borsa İstanbul.
- (13) VAT is not included in the fees specified in the Addendum-3 Borsa İstanbul Data Fee Schedule. Banking and Insurance Transactions Tax (BITT) is included in the fees related to İstanbul Takas ve Saklama Bankası (Takasbank) Data.
- (14) Fees specified for TR Local shall be paid for real persons, corporations and legal entities resident in Turkey whereas fees specified for Overseas shall be paid for real persons, corporations and legal entities resident abroad.
- (15) Borsa İstanbul members may use the last trade price and best bid/ask prices free of charge provided that the prior approval of Borsa İstanbul is obtained and it shall be limited to the order entry dialogs/window of Borsa İstanbul members in such a way that the prices are updated only at the launch of order entry dialogs/window without containing the continuous update of the prices.
- (16) Monthly Variable Fees will not be applied for the distribution of last trade price and best bid/ask prices for the contracts based on the currencies or the precious metals that are traded in Borsa İstanbul Futures & Options Market.
