Subject : Announcement on New Sector Indices to Be Calculated

Dear General Manager
Dear Member

Equity Indices are periodically reviewed by the Borsa İstanbul Financial Benchmarks Committee (the “Committee”), amendments arising from developments in the markets as well as changes in local and international regulations are reflected in the Methodologies, requests received from market participants and deemed appropriate are accommodated, and the related updates are implemented accordingly.

Within this framework, it has been decided by the General Management of Borsa İstanbul that:

- The “BIST Wholesale Trade Index”, consisting of the shares of companies classified under the “Wholesale Trade” sector, will be calculated and, with the calculation of the index, the shares included in the Wholesale Trade sector will continue to remain within the scope of the BIST Services top sector index and the BIST Trade main sector index,
- the “BIST Retail Trade Index”, consisting of the shares of companies classified under the “Retail Trade” sector, will be calculated and, with the calculation of the index, the shares included in the Retail Trade sector will continue to remain within the scope of the BIST Services top sector index and the BIST W. and Retail Trade main sector index,
- the “BIST Accommodation Index”, consisting of the shares of companies classified under the “Accommodation” sector, will be calculated and, with the calculation of the index, the shares included in the Accommodation sector will continue to remain within the scope of the BIST Services top sector index and the BIST Tourism main sector index,
- the “BIST Food and Beverage Services Index”, consisting of the shares of companies classified under the “Food and Beverage Services” sector, will be calculated and, with the calculation of the index, the shares included in the Food and Beverage Services sector will continue to remain within the scope of the BIST Services top sector index and the BIST Tourism main sector index,

- the “BIST Venture Capital Investment Trust Index”, consisting of the shares of companies classified under the “Venture Capital Investment Trusts” sector, will be calculated and, with the calculation of the index, the shares included in the Venture Capital Investment Trusts sector will continue to remain within the scope of the BIST Financials top sector index while being excluded from the scope of the BIST Hold. and Investment sector index,
- no amendments will be made to the BIST Market Cap Weighted Stock Indices Methodology (the “Methodology”) due to the calculation of the aforementioned indices, as such indices are sector indices and are not separately specified in the Methodology,
- the indices will start to be calculated as of May 18, 2026 with the index codes and base values specified below and with the shares included in the attached lists.
