Dear Members.

The fees for Borsa İstanbul Colocation and Colocation Data Services has been changed with the effective date of January 1st, 2026.

Please kindly find the Appendix-1 of the Colocation Data Agreement and Price List of Colocation Agreement attached.

The updated forms and prices will be in effect starting from January 1st, 2026.

Please note that there will be a change regarding Market Connectivity. Starting from March 1st, 2026, Market Connectivity will not be offered separetly for each market. Instead, it will be offered as a bundle for all markets.

Since members can access the Equity Market and the Futures and Options Market through the all market connections provided to their cabinets located at the colocation, it is deemed appropriate to remove the market-based distinction in the allocation and pricing of market connections.

To provide members a transition period if they prefer to make changes in their existing connections, the new pricing model is scheduled to go into effect on March 1, 2026.
