Subject: Announcement About Declarations of Training Statistics on Responsible Supply Chain

Regulations for the year 2021.

To Whom It May Concern

According to the first paragraph of article 16, titled "Training Activities", of Borsa İstanbul A.Ş.

Directive on Internal Control System and Compliance Principles of Precious Metals Intermediary

Institutions and Refineries (Directive) within the scope of responsible supply chain, obligors are under

obligation to conduct training activities with respect to their corporate size, business volume and the

changing conditions. In the third paragraph of above-cited article, it is stipulated that the training

activities must be repeated at least once a year as needed. Training subjects must include the topics in

Article 17 of the Directive. According to article 18 of the Directive, information and statistics related

to the training activities are required to be reported and notified to Ministry of Treasury and Finance

and Borsa İstanbul A.S. by the internal control and supply chain compliance officer at the end of March

of the following year. Aforementioned notification can be made through Borsa İstanbul Responsible

Supply Chain Training Information Form on Borsa İstanbul A.Ş. Custody Application.

In this regard, notification of training activities for the year 2021 must be made through Borsa İstanbul

Responsible Supply Chain Training Information Form on Borsa İstanbul A.Ş. Custody Application

until March 31, 2022.

On the other hand, due to the fact that 2021 was the first year that responsible supply chain regulations

came into effect and covered only a period of six months, it is deemed necessary for the year to be

regarded as a transition period considering the possibility that the organizational infrastructures of the

obligors to carry out the required training activities at the desired level and scope are not matured as a

consequence of the new start of the process. Therefore, only for the year 2021, provided that internal

control and compliance officers or contact persons of obligors attended any of the trainings organized

by Borsa İstanbul A.Ş. on December 8 and December 16, 2021, it will be deemed that obligors gave

the same training to the relevant staff of their institutions, covering all the training topics in the Article

17 of the Directive, hence; training requirement will be deemed to be fulfilled for the year 2021.

Accordingly, regarding the training statistics for the year 2021, information regarding the training

provided by Borsa İstanbul A.Ş. and/or other trainings provided by your institution should be reported

on Borsa İstanbul A.Ş. Custody Application via Borsa İstanbul Responsible Supply Chain Training

Information Form.
