Subject: Announcement about the modifications in the current business classification system and changes to some companies' sectors and indices.

To Whom It May Concern

In order to split and regroup some activities grouped in the same main sector it has been decided to make the following modifications in the current business classification system and due to this modification, it has been decided to make the following changes effective from June 1, 2022.

- 1) In addition to existing “Information Services Activities” sector, following sectors will be added to “INFORMATION AND COMMUNICATION” main sector,
 - “Publishing”,
 - “Telecommunication”
- 2) Name of “Paper and Paper Products Printing and Publishing” sector under the “MANUFACTURING” main sector, will be changed as “Paper and Paper Products Printing” by excluding the publishing activities. Publishing activities will be included in “Publishing” sector under “INFORMATION AND COMMUNICATION” main sector.
 - a) Doğan Burda, Hürriyet Gazetecilik and İhlas Gazetecilik stocks will be classified under the new “Publishing” sector under “INFORMATION AND COMMUNICATION” main sector.
 - b) Doğan Burda, Hürriyet Gazetecilik and İhlas Gazetecilik stocks will be excluded from BIST Industrials and BIST Wood Paper Printing indices and will be included in BIST Services index.
- 3) Name of “WHOLESALE AND RETAIL TRADE RESTAURANTS AND HOTELS” main sector will be changed as “WHOLESALE AND RETAIL TRADE” by excluding the hotels and restaurants. Restaurants and hotels will be classified under the new “HOTELS AND RESTAURANTS” main sector.
- 4) There will be two new sectors under the new “HOTELS AND RESTAURANTS” main sector;
 - “Accommodation”,
 - “Food and Beverage Services”
 - a) Avrasya Petrol ve Tur., Altinyunus Çeşme, Kuştur Kuşadası Turizm, Marmaris Altinyunus, Martı Otel, Merit Turizm, Petrokent Turizm, Tek-Art Turizm and Ulaşlar Turizm Yat. stocks will be classified under “Accommodation” sector under the new “HOTELS AND RESTAURANTS” main sector.

- b) Do-Co and Etiler Gıda stocks will be classified under “Food and Beverage Services” sector under the new “HOTELS AND RESTAURANTS” main sector.
 - c) Do-Co stocks will be excluded from BIST Transportation Index and will be included to BIST Tourism Index.
- 5) Name of “TRANSPORTATION STORAGE AND COMMUNICATION” main sector will be changed as “TRANSPORTATION AND STORAGE” by excluding the communication activities. Communication activities will be classified under the new “Telecommunication” sector under “INFORMATION AND COMMUNICATION” main sector.
- a) Türk Telekom and Turkcell stocks will be classified under “Telecommunication” sector under “INFORMATION AND COMMUNICATION” main sector.
