Subject: Announcement about the changes in the BIST
Leveraged and Short Indices Methodology

To Whom It May Concern

BIST Leveraged and Short Indices Methodology are periodically reviewed by the Borsa İstanbul Financial Benchmarks Committee (Committee), reflecting developments in the markets and changes arising from local and international legislation, meeting requests received from market participants that are deemed appropriate, and making the necessary updated accordingly.

Borsa İstanbul Management has decided to make the following changes on the BIST Leveraged and Short Indices Methodology without changing calculation method (formula),

- Rewriting the format due to needs encountered in practice,
- In line with other Borsa İstanbul Methodologies;
 - Changing the main heading numbered 1, which is currently “DEFINITION” to “INTRODUCTION”, and opening the subheadings “Purpose”, “Management”, “Financial Benchmarks Committee” and “Methodology Changes”
 - Changing the main heading numbered 2, which is currently “CALCULATED INDICES” to “ABBREVIATIONS, DEFINITIONS AND GENERAL RULES” and the subheadings in this section listed as follows “Abbreviations”, “Calculation and Dissemination Frequency”, “Data Precision”
 - Changing the main heading numbered 3, which is currently “CALCULATION METHODOLOGY” to “CALCULATED INDICES; STARTING DATES AND VALUES”
 - Changing the main heading numbered 4, which is currently “DATA PRECISION” to “CALCULATION METHODOLOGY”
 - Changing the main heading numbered 5, which is currently “MISCELLANEOUS” to “CORRECTION IN INDEX VALUES”
 - Adding the main headings “UPDATE FREQUENCY 6” and “EFFECTIVE DATE 7” respectively
 - Adding a statement to the article titled “Management” stating that “*Borsa Istanbul is the owner of the intellectual property rights of all indices calculated under this methodology*”

It has been decided to amend the Methodology by making changes presented in Appendix 1, and to implement the changes as of October 10, 2025. The final version of the Methodology is provided in Appendix 2.
